THE TRAINING SESSION LASTS ABOUT AN HOUR. CANDIDATES ARE ENCOURAGED TO REGISTER WITH THE ELECTION OFFICE BEFORE NOON ON FRIDAY, JUNE 14, 2019.

Tuesday January 22	5:00 p.m. Last date and time for all candidates and non-elected Public Officials to file their 2018 Campaign Finance report. M.G.L. Chapter 55, § 18. Period covered is 01/01/2018 – 12/31/2018.
Monday May 6	8:15 a.m. Nomination papers available for candidates. Nomination papers can only be furnished to the candidate or individual authorized in writing by the candidate to obtain papers on the candidate's behalf. Candidate shall file a statement containing the candidate's name, address and office for which he/she will be a candidate before obtaining the nomination papers. The Statement appears on the Nomination papers. M.G.L. Chapter 53.
Tuesday June 18	6:00 p.m. Office of Campaign and Political Finance training session conducted by Mr. Jason Tait, Director of Communications and Public Education, Office of Campaign and Political Finance. The training session is held in the City Council Chambers, Revere City Hall, 281 Broadway, Revere, MA.
Tuesday July 23	5:00 p.m. Last date and time to submit nomination papers to the Election Commissioners for certification of signatures.
Wednesday August 7	5:00 p.m. Post List of Candidates – M.G.L. Chapter 43, Section 44D.
Thursday August 8	5:00 p.m. Last date and time for filing withdrawals of or objections to nomination papers. M.G.L. Chapter 55B, §7.
Friday August 9	10:00 a.m. Drawing by the Election Commissioner for the candidate's position on the preliminary ballot if there are a sufficient number of candidates to warrant a preliminary. Drawing is held in the Election Department. M.G.L. Chapter 43, § 44D.
Wednesday August 21	8:00 p.m. Last date and time to register to vote for the September 10, 2019 preliminary. M.G.L. Chapter 51, § 26.
Tuesday September 3	5:00 p.m. Last date and time for candidates on the ballot to file their first Campaign Finance report for 2019. Period covered 01/01/2019 – 08/23/2019. When a preliminary is not held, <b>no</b> report is due. M.G.L. Chapter 55, § 18.
Tuesday September 3	5:00 p.m. Last date and time to post the warrant for the preliminary.
Monday September 9	12:00 noon, Last date and time to file an application for an absentee ballot for the preliminary. M.G.L. Chapter 54, § 89.

*TUESDAY, September 10, 2019, PRELIMINARY ELECTION. POLLS OPEN AT 7:00 A.M. AND CLOSE AT 8:00 P.M.*

Monday  
September 16 5:00 p.m. Last date and time for filing withdrawals of or objections to nominations made at the preliminary and for filing written acceptances by write-in or sticker candidates who won in the preliminary. The last day to file a recount petition. M.G.L. Chapter 54, § 135.

Wednesday  
October 16 8:00 p.m. Last date and time to register to vote for the Municipal Election.

Monday  
October 28 5:00 p.m. Last date and time for all candidates and non-elected public officials to file their second Campaign Finance report for 2019. Period covered is 08/24/19 to 10/18/19. M.G.L. Chapter 55, § 18. If a preliminary is not held the period covered is 01/01/2019 - 10/18/2019.

October 29 5:00 p.m. Last date and time to post the warrant for the Municipal Election.

Monday  
November 4 12:00 Noon, Last date and time to file an application for an absentee ballot for the November 5, 2019 Municipal Election.
