Hearing: Hearing of Rogers Realty of Revere, Inc. d/b/a Shipwreck Lounge, Louis Padova, Manager, to address police reports of serving alcoholic beverages after 2:00 a.m. closing time.

Louis Padova appeared for the hearing. Sgt. Patricia Carey of the RPD described the incident, in which she found several people still drinking at the bar after 2:00 a.m. Mr. Padova contended that it was an isolated incident, and that the Commission would never need to call him in again, acknowledging that he had said the same thing on the last occasion of violating the closing hour. Mr. Padova attributes the violation to an innocent mistake caused by a

drunken man walking into the bar while the senior citizen bartender was outside waiting for her ride home on a Monday night, when no police were expected. He assured the Commission that he would make changes to avoid future violations.

Upon a motion duly made by Chairman Quarantello, and seconded by Commissioner LaCroix, it was voted to table the matter for six months, pending further violations.
